

The meeting was conducted in principal's office on 07/12/2020 at 4.00 PM.

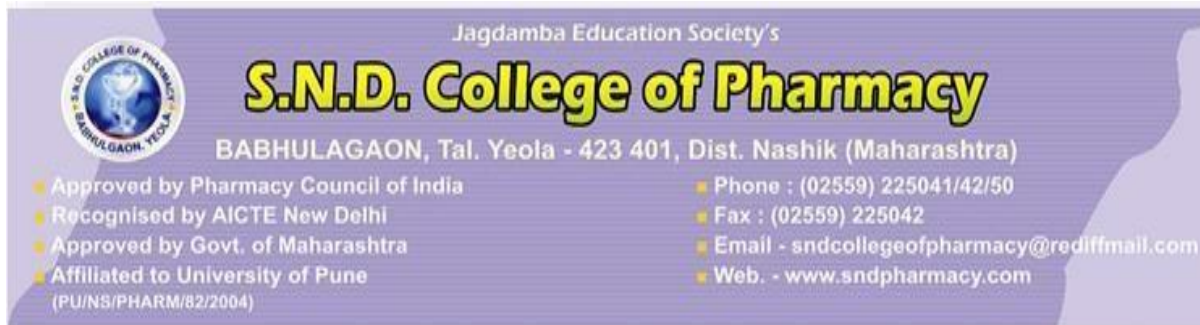
The meeting was headed by respected principal Dr. R.S. Kalkotwar.

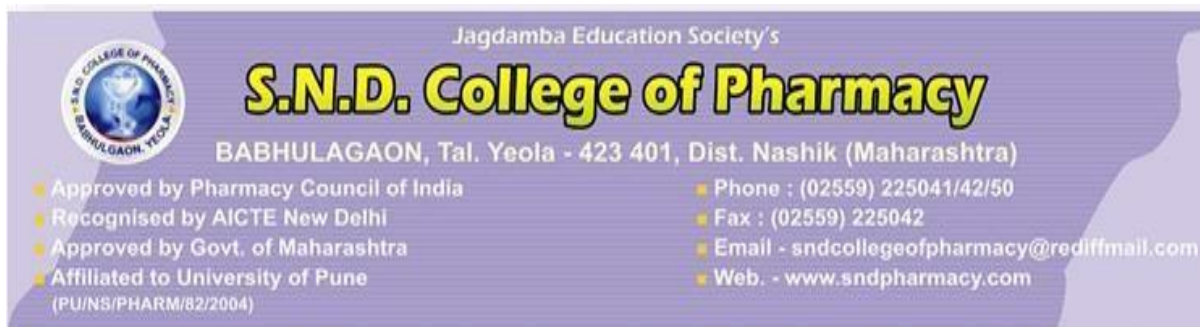


